letting go of high-return projects for lack of enough security. Through a planned exit strategy, today Milestone has returned over Rs. 3200 crores back to their investors. Under her leadership, Milestone concluded fund raise and investments from its 9th fund, India's first structured debt real estate fund, which as per many independent reports, at 22% gross IRRs, could be one of India's best performing PERE funds. Recently exiting one of its marquee assets, 247Park in Mumbai for Rs. 1060 crores, Rubi achieved one of India's largest PERE exits and rewarded Milestone's investors with over 21% IRR just from this asset alone.

Having raised & invested over Rs. 2800 crores in real estate itself and having returned over INR 3000 crores across all funds, with undivested capital of over Rs 800 crores, Rubi has brought to light a new form of entrepreneurship.
